SETTLEMENT AGREEMENT

THIS SETTLEMENT AGREEMENT ("Agreement") is made this 3rd day of August, 2004 between the Insurance Department of the Commonwealth of Pennsylvania ("Department") and Allen J. Perry and Senior Benefits Group, Inc. Allen J. Perry is the owner and sole qualifying active officer of Senior Benefits Group, Inc.; both are collectively referred to herein as "Respondents."

BACKGROUND

WHEREAS, on May 25, 2004, the Department filed an Order to Show Cause against Respondents with the Administrative Hearings Office under Docket No. SC04-05-047.

WHEREAS, the Order to Show Cause alleged that Respondents violated the Insurance

Department Act and Pennsylvania Insurance Regulations by committing the following felonies to which Perry pleaded guilty on February 17, 2004: 10 consolidated counts of selling unregistered securities (70 P.S. §1-201); 10 consolidated counts of acting as an unlicensed broker (70 P.S. §1-301(a)); and 10 consolidated counts engaging in fraudulent or prohibitive practices (70 P.S. §1-401(b) and (c)),

WHEREAS, the dispute between the Department and Respondents resulted in litigation in the Department's Administrative Hearings Office. In an effort to settle the dispute arising out of Respondent's conduct, as alleged in the Order to Show Cause, the parties hereto have agreed to settle, *inter alia*, all claims asserted in the litigation at docket number SC04-05-047 and all claims which the Department, on the one hand, and Respondents, on the other hand, have against each other, arising out of, or in relation to, the activities and conduct described in the Order to Show Cause, all subject to and on the terms and conditions hereinafter set forth.

AGREEMENTS

The parties hereto, intending to be legally bound, hereby agree as follows:

1. Respondents shall, immediately upon the signing of this Settlement Agreement, cease and desist from the activities and conduct identified in the Order to Show Cause filed by the Department under docket number SC04-05-047 on May 24, 2004.

2. Respondents shall cease and desist from all illegal and otherwise improper activities or conduct that may constitute a violation of the Commonwealth's insurance laws.

3. Respondents hereby agree to permanent revocation of any and all insurance licenses, Certificates of Qualification and broker licenses issued to Respondents.

4. Respondents may not apply for re-licensure in any capacity by the Department.

5. This Settlement Agreement is intended only to resolve the litigation between the Department and Respondents resulting from the Order to Show Cause filed under docket number SC04-05-047 on May 24, 2004. Further, this Settlement Agreement does not constitute and shall not be construed as the Department's written consent to engage in the business of insurance pursuant to 18 U.S.C. §§1033, 1034.

6. For and in consideration of Respondents' release and discharge of the Commonwealth of Pennsylvania and the Department from any action, claim or demand arising out of the activities and conduct identified in or relating to the Order to Show Cause, the Commonwealth of Pennsylvania and the Department hereby release and discharge Respondents from any claims in any court or administrative proceeding which the Commonwealth of Pennsylvania and/or the Department have or may have as a result of the allegations made in the Department's Order to Show Cause filed under docket number SC04-05-047 on May 24, 2004.

7. For and in consideration of the Commonwealth of Pennsylvania's and the Department's release and discharge of Respondents from any action, claim or demand arising out

of the activities and conduct identified in or relating to the Order to Show Cause, Respondents hereby release and discharge the Commonwealth of Pennsylvania and the Department from any claims in any court which Respondent have or may have as a result of the allegations made in the Order to Show Cause filed under docket number SC04-05-047 on May 24, 2004.

8. Captions used herein are for convenience only, and are not a part hereof, and shall not be used in construing this Settlement Agreement.

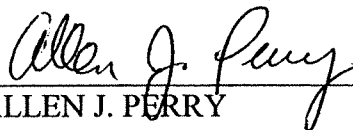

This Settlement Agreement shall be binding upon, and inure to the benefit of, the parties hereto and their respective successors and assigns, and, in addition hereto, shall be binding upon any receiver, liquidator, rehabilitator, conservator, supervisor and any other person or entity, governmental or non-governmental, exercising or seeking to exercise the powers of the persons named above.

10. This Settlement Agreement shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania.

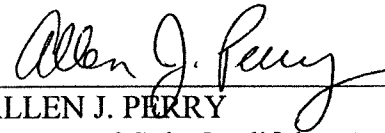

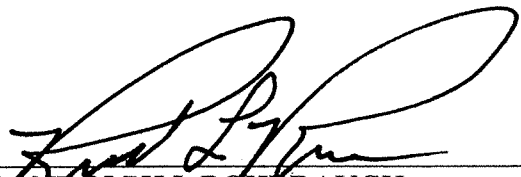
